IT TAKES A VILLAGE

Finding Strength & Resilience in Community: The Ismael-Gantt's Foster Care Journey





As parents to five boys, Patrice and Jessica Ismael-Gantt ar familiar with the joys and chaos that a full house can bring. And they know they have others they can lean on if they need support.

The Ismael-Gantt's journey as a foster family began in 2016 after UMFS visited their church and talked about the need for foster parents in the region. The couple started taking classes with UMFS and were excited about what kind of parents they would be and how they could help a child. The went into the process wanting to foster, knowing that the goal would be reunification.

"The trainings were very enlightening because we learned about all the resources that were available for us," shared Patrice. "You think, okay, what if I don't know what to do? What if I don't have the right tools to help them? UMFS really assured us that we wouldn't be alone. They walked us through case studies and role plays to see how we would react and what kind of parents we would be."

"You also learn a lot about yourself through the trainings," said Jessica. "I learned about my strengths, what I'm good at, and even my triggers. I think the trainings set us up for success."

In addition to connecting them with resources, UMFS' sessions also connected Patrice and Jessica with other families going through the same process.

"The connection you make with other foster parents during the training class is even more amazing because you get this great set of families that you can lean on when you need help, when you have challenges, or even when you need respite," Patrice shared.

Because so many children in treatment foster care have experienced trauma, they often need a higher level of support and resources, and knowing how to respond to their behavior is a skill set that parents and extended family have to learn. Comparents that are on the edge about becoming foster or adoptive parents, they shared insightful advice. "If you want to become a parent, this is an amazing way to

Relationships with other foster parents and families are crucial explained Patrice.

"You know that they've received the same training, so when we need a break, we feel safe taking a respite, or even swapping our kids for a day. We also have fun together. Our children get to spend time around each other which is so important."

"The friendships we've created over the years have really helped us through this journey," added Jesscia. They ended up falling in love with their foster children and when the two oldest kids became available for adoption, it was very easy for them to take the next step. Unlike many other Treatment Care Foster agencies, UMFS certifies parents as foster parents and adoptive parents from the

They also believe that their youngest children are future engineers and architects.

"There's always someone you can call. It takes a **village**, and **UMFS is a village**."

"If you want to become a parent, this is an amazing way to help out another child and another parent that wasn't able to be one," said Patrice. "If you've even considered it, just come to the class. There's a kid out there just wants and needs attention, love and consistency. If you can provide those three things, everything else will fall into place."

"We have so many kids in Hampton Roads that need care, and we really want as many people to offer their help as possible," Jessica said.

"I think that a lot of people are scared that they're going to be alone, but when you go through an agency like UMFS, you're not alone." Patrice said. "There's always someone you can call. It takes a village, and UMFS is a village."

Space will also be donated to mission-aligned nonprofit partners, our Generosity Collective, who help maximize our impact and stack wins for the community.


Thanks to the generosity of many donors, we successfully met the challenge grant offered by The Cabell Foundation, bringing our current fundraising total to \$600,000!



PROJECT LIFE








